

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2010 Child Care & Development Fund Mandatory Carry Forward
Funds from Grant Year FY2009)

RESOLUTION NO. 10-237

1 **WHEREAS, the Tohono O'odham Nation is operating the Division of Early Childhood Development**
2 **for its young members and providing for their welfare through various program and**
3 **services designed to meet their special needs; and**

4 **WHEREAS, the Department of Health and Human Services, Administration for Children and**
5 **Families has awarded the Tohono O'odham Nation the Child Care & Development**
6 **Fund for Grant Year 2009 to implement Child Care Services through the Division of**
7 **Early Childhood Development; and**

8 **WHEREAS, the Child Care & Development Fund is a multi-year grant in which Grant Year 2009**
9 **Carry Forward Mandatory Funds will be obligated by September 30, 2010 and**
10 **liquidated by September 30; and**

11 **WHEREAS, the Division of Early Childhood Development has submitted for review and approval**
12 **the proposed Carry Forward Funds for Child Care & Development Fund Mandatory**
13 **Funds for Grant Year 2009 totaling \$159,041.00; and**

14 **WHEREAS, the Grant Year 2009 CCDF Mandatory Carry Forward funds budget has been reviewed**
15 **by the Human Resources Development Committee and the Budget and Finance**
16 **Committee.**

17 **NOW, THEREFORE, BE IT RESOLVED that The Tohono O'odham Legislative Council does hereby**
18 **approve the FY2010 Carry Forward Funds for the Child Care & Development Fund from**
19 **Grant Year 2009 Mandatory Carry Over Funds for a one-time funding total of**
20 **\$159,041.00 for the following budget as attached hereto.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
22 **Nation's Official, to wit: the Chairman and any designated official are authorized to**
23 **negotiate and expend the budget, provided however, that any amendments affecting**
24 **the funds or funding levels of the budget shall be submitted for further prior approval.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24TH Day**
26 **of JUNE, 2010 at a meeting at which a quorum was present with a vote of 2,408.40 FOR; -0- AGAINST;**
27 **-0- NOT VOTING; and 187.10 [04] ABSENT, pursuant to the powers vested in the Council by Article**
28 **VI, Section 1 (d)(2)(3) and (f) of the Constitution of the Tohono O'odham Nation, adopted by the**
29 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat. 984).**
