8	WHEREAS, the allocation increase is reflected in the addition of a new line item 816, Child Care
9	Certificates; and
10	WHEREAS, the FY2010 CCDF Discretionary Funds, Budget Amendment No. 1, Account No. 11-1220
11	has been reviewed and approved by the Human Resources Development Committee
12	and Budget and Finance Committee.
13	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby
