2	the deposit of generated revenues including donations and contributions received;

4	WHEREAS, all proceeds, net revenues, donations and contributions are restricted to Public
5	Relations expense including monetary donations given to individuals, groups and also
6	for payment of district profit share pursuant to an executed agreement; and
7	WHEREAS, KOHN has received and deposited a payment of underwriting sponsorship in the
8	amount of \$2,175.00 and has prepared the attached budget to utilize these revenues;
9	and
10	WHEREAS, it is necessary for KOHN to request approval from the Tohono O'odham Legislative
11	Council to expend the amount deposited into the Dedicated Revenue Account 01-3038
12	for Public Relations purposes.
13	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
14	and authorizes KOHN to expend the Dedicated Revenue Account 01-3038 for Public
	Relations expenses as provided in the attached budget.

16	BE IT FURTHER RESOLVED that any changes to the funding level of the Dedicated Revenue Account
17	01-3038 shall not be expended unless a budget has been adopted by this Council.
18	BE IT FINALLY RESOLVED that Public Relations expenses include monetary donations given to
19	individuals, groups and also payment to the Gu-Achi District for profit sharing due to
20	memorandum of agreement.
21	The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the $24^{\mathrm{TH}}$ Day
22	of IUNE, 2010 at a meeting at which a quorum was present with a vote of <u>2,408.40</u> FOR; <u>-0-</u> AGAINST;
23	<u>-01- NOT VOTING</u> ; and <u>187.10[04]</u> ABSENT, pursuant to the powers vested in the Council by Article
24	VI, Section 1 (d)(2)&(3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
25	O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary
26	Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
27	Stat. 984).
