

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2010 Budget Amendment #2 for GSS/Motor Pool)**

RESOLUTION NO. 10-242

1 WHEREAS, Tohono O'odham Legislative Resolution No. 09-268 adopted and approved the  
2 Executive Branch Fiscal Year 2010 Tribal Budgets; and

3 WHEREAS, Motor Pool under the General Support Services has been notified that the hourly rate  
4 for the Mechanic Supervisor position has been incorrectly paid since June 2008; and

5 WHEREAS, the Nation's Motor Pool submits for review and approval the attached FY2010 Budget  
6 Amendment Number 2; and

7 WHEREAS, the budget is amended to increase 610 Salaries in the amount of \$11,551.40, which is  
8 the salary owed and 620 Fringe Benefits in the amount of \$3,927.48, which is the  
9 calculated fringe associated with the corrected hourly rate; and

10 WHEREAS, Fiscal Year 2010 Budget Amendment No. 2 for the Nation's Motor Pool has been  
11 reviewed by the Legislative Budget and Finance Committee.

12 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby  
13 approve Amendment No. 2 to the Tohono O'odham Nation Motor Pool Budget for the  
14 said position, and authorizes a one-time appropriation in the amount of \$15,478.88  
15 from the general surplus fund of the Nation, as per attached budget.

16 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham  
17 Nation Chairman, Vice-Chairman and any designated officials are authorized to  
18 administer the budget as attached, provided however, that any amendments affecting  
19 the funds or funding level shall be submitted for further prior approval by the Tohono  
20 O'odham Legislative Council.

21 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24<sup>TH</sup> Day  
22 of JUNE, 2010 at a meeting at which a quorum was present with a vote of 2,408.40 FOR; -0- AGAINST;  
23 -0- NOT VOTING; and 187.10[03] ABSENT, pursuant to the powers vested in the Council by Article  
24 VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the  
25 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
26 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
27 18, 1934 (48 Stat. 984).
