

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving of Pia-oik Community Budget Amendment No. 1 in the Amount of
\$12,100.00 for Fiscal Year 2010)

RESOLUTION NO. 10-246

1 **WHEREAS, the Gu-Vo District did bring forth the Pia-Oik Community's Amendment No. 1 for the**
2 **Fiscal Year 2010 Budget; and**

3 **WHEREAS, the Pia-Oik Community is requesting adjustment to the justification line item 852 and**
4 **adding funds in line items that are depleting in their FY' 2010 Budget to assist the**
5 **Community Members; and**

6 **WHEREAS, the proposed amendment from the Pia-Oik Community has gone through proper**
7 **reviews from the Gu-Vo District and the Tohono O'odham Legislative Budget and**
8 **Finance Committee; and**

9 **WHEREAS, it is the recommendation of the Budget and Finance Committee to approve**
10 **Amendment #1 for the Pia-Oik Community amending justification line item 852 and**
11 **adding funds into the line items that are depleting, 712, 727, and 810.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
13 **the Budget Amendment #1 for Pia-Oik Community to add funds to line items that are**
14 **depleting and amending justification of line item 852 Donation/Contribution, the**
15 **original justification states;**

16 **"To provide donation to each head of household members for Thanksgiving and**
17 **Christmas Holiday Dinner. Budgeted @\$200.00 per holiday x 20 house hold= \$8,000.00**
18 **(First Come First Serve)**

19 **1. To provide purchase of appliance/furniture to each head of household. Budgeted**
20 **@ \$1,000.00 per household x 20 household= \$20,000.00 (First Come First Serve).**

21 **2. To purchase exercise machines for community youth/members to utilize,**
22 **budgeted @ \$1,000.00.**

23 **3. To purchase youth sports equipment, budgeted @ \$2,000.00.**

24 **4. To purchase appliances for community building and feast house, including but not**
25 **limited to; refrigerator, freezer, microwave, vacuum etc.-Budgeted @ \$3,000.00.**

26 **And the amended justification that has been added is as follows;**

27 **"\$1,000.00 designated for the purchase of two (2) AC Units for the Community Feast**
28 **House, and \$1,100.00 is designated to purchase two (2) Evaporated Coolers for the**

6 **of JUNE, 2010 at a meeting at which a quorum was present with a vote of 2,408.40 FOR; -0- AGAINST;**
7 **-0- NOT VOTING; and 187.10[04] ABSENT, pursuant to the powers vested in the Council by Article**
8 **VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the**
9 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
10 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
11 **18, 1934 (48 Stat. 984).**
