

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving of Kukatch Community Carry Over Plane Crash Settlement Funds
into FY' 2010 in the amount of \$17,681.40)**

RESOLUTION NO. 10-247

1 **WHEREAS, the Gu-Vo District Governing Council did meet on June 15, 2010 to approve Kukatch**
2 **Community Carry Over Plane Crash Settlement Funding into FY' 2010; and**

3 **WHEREAS, the community does not have running water and has been transporting water; and**

4 **WHEREAS, the community has approved to purchase a water truck for their community with the**
5 **funding; and**

6 **WHEREAS, the current community budget for FY' 2010 is \$253,101.58, the Plane Crash Settlement**
7 **Fund is \$17,681.40, the grand total for FY' 2010 is \$270,782.98; and**

8 **WHEREAS, the Gu-Vo District Governing Council has determined that it is in the best interest of**
9 **Kukatch Community to request to the Tohono O'odham Legislative Council to grant**
10 **Kukatch Community to Carry Over the Plane Crash Settlement in the amount of**
11 **\$17,681.40 in to FY' 2010; and**

12 **WHEREAS, it has gone through proper reviews from the Gu-Vo District and the Tohono O'odham**
13 **Legislative Budget & Finance Committee, it is the recommendation of the Budget &**
14 **Finance Committee to approve Kukatch Community Carry Over.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
16 **the Kukatch Community to Carry Over Plane Crash Settlement Funds in the amount**
17 **of \$17,681.40 into FY' 2010. The total overall budget for Gu-Vo District is \$2,080,184.19**
18 **for FY' 2010.**

19 **BE IT FINALLY RESOLVED that the Gu-Vo District reserves the right to modify its budget according**
20 **to the Tohono O'odham Nation's process, but any amendments affecting the funds or**
21 **funding level shall be approved by the Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24TH Day**
23 **of JUNE, 2010 at a meeting at which a quorum was present with a vote of 1,543.60 FOR; 159.0**
24 **AGAINST; 705.80[06] NOT VOTING; and 187.10[03] ABSENT, pursuant to the powers vested in the**
25 **Council by Article VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation,**
26 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
27 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act**
28 **of June 18, 1934 (48 Stat. 984).**
