

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Creation of a New Budget for South Komelic Community, Utilizing
Mining Royalties)

RESOLUTION NO. 10-250

1 **WHEREAS, at an emergency session of the Tohono O'odham Legislative Council, held on June 24,**
2 **2010; and**

3 **WHEREAS, Baboquivari District Representatives presented a request to create a new budget, for**
4 **South Komelic Community, utilizing mining royalties of \$17,741.37, per Baboquivari**
5 **District Resolution No. 09-B-163; and**

6 **WHEREAS, the new budget would create one line item, 727.32 Building Materials, in the amount**
7 **of \$17,741.37; and**

8 **WHEREAS, this new budget would not affect South Komelic Community's FY 2010 original budget**
9 **amount of \$186,307.28, but would increase the overall Baboquivari District's FY 2010**
10 **current budget amount of \$1,934,038.25 to \$1,951,779.62.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves South**
12 **Komelic Community's new budget creation to utilize mining royalties in the amount**
13 **of \$17,741.37 and utilizing one line item 727.32 Building Materials in the amount of**
14 **\$17,741.37.**

15 **BE IT FURTHER RESOLVED that this new budget creation will not affect South Komelic**
16 **Community's FY 2010 budget of \$186,307.28, but will increase the overall FY 2010**
17 **current budget for Baboquivari District of \$1,934,038.25 to \$1,951,779.62.**

18 **BE IT FINALLY RESOLVED that any modifications, amendments or changes in the justifications**
19 **shall be reviewed and approved by the Budget and Finance Committee and the Tohono**
20 **O'odham Legislative Council.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24TH Day**
22 **of JUNE, 2010 at a meeting at which a quorum was present with a vote of 2,408.40 FOR; -0- AGAINST;**
23 **-0- NOT VOTING; and 187.10[03] ABSENT, pursuant to the powers vested in the Council by Article**
24 **VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the**
25 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
27 **18, 1934 (48 Stat. 984).**
