RESOLUTION NO. 10-252

1 **WHEREAS, the Legislative Council by Resolution No. 09-517 and by Res. No. 10-057 approved the**  
2 **Hikiwan District Administration and seven Community budgets in the amount of**  
3 **\$1,902,104.09; and**

4 **WHEREAS, the Hikiwan District Council is now presenting the S-tuha Bidag Community Budget**  
5 **Modification/Amendment No. 01 for FY2010 in the amount of \$37,000; and**

6 **WHEREAS, the S-tuha Bidag Community is adding additional language to its FY2010 Budget**  
7 **Justification for Line Items 852 and 860; and**

8 **WHEREAS, the Hikiwan District council by Res. No. HDC-10-033 approved the S-tuha Bidag**  
9 **Community FY2010 Budget Modification/Amendment No. 01, and requests approval**  
10 **by the Tohono O'Odham Legislative Council.**

11 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it hereby**  
12 **approves Hikiwan District Council Resolution No. HDC-10-033, which approves the**  
13 **FY2010 Budget Modification/Amendment No. 01, for the S-tuha Bidag Community to**  
14 **add additional language to Line Items 852 and 860 of the FY2010 Budget Justification.**

15 **BE IT FURTHER RESOLVED that the Tohono O'Odham Legislative Council hereby authorizes the**  
16 **Chairperson and any designated official to expend and administer the budget as**  
17 **attached; provided that any amendments affecting the funds or funding level shall be**  
18 **submitted for further prior approval by the Tohono O'Odham Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24<sup>TH</sup> Day**  
20 **of JUNE, 2010 at a meeting at which a quorum was present with a vote of 2,209.70 FOR; -0- AGAINST;**  
21 **198.70[03] NOT VOTING; and 187.10[04] ABSENT, pursuant to the powers vested in the Council by**  
22 **Article VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
23 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
25 **18, 1934 (48 Stat. 984).**
