1	WHEREAS, the Gu-Vo District Governing Council did meet on June 19, 2010 to approve Kukatch
2	Community Budget Amendment No. 2 for FY'2010; and
3	WHEREAS, the Gu-Vo District Governing Council has determined that it is in the best interest of
4	the Kukatch Community to request to the Tohono O'odham Legislative Council to
5	grant Kukatch Community approval to increase and amend justification in line item
6	750 Major Capital Equipment for FY'2010; and
7	WHEREAS, it has gone through proper reviews from the Gu-Vo District and Tohono O'odham
8	Legislative Budget and Finance Committee; and
9	WHEREAS, it is the recommendation of the Budget and Finance Committee to approve
10	Amendment No. 2 for the Kukatch Community increasing and amending justification.
11	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
12	the Budget Amendment No. 2 for Kukatch Community in increasing and amending
13	justification of line item 750 Major Capital Equipment, the original justification states:
	"To provide for purchasing a tractor with all attachments and accessories as needed
14	
15	by the community members. After a tractor is purchased, the variance will be used to
16	purchase furnishings for the community modular building; such as but not limited to
17	desk; living room set; television; coffee tables; shelves; etc."
18	And the amended justification that has been added is as follows:
19	"Purchase water truck with all necessary parts and equipment to be utilized by the
20	community members."
21	BE IT FINALLY RESOLVED that the Gu-Vo District reserves the right to modify its budget according
22	to the Tohono O'odham Nation's process, but any amendments affecting the funds or
23	funding level shall be submitted for further prior approval by the Tohono O'odham
24	Legislative Council.
25	The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the $24^{ m TH}$ Day
26	of JUNE, 2010 at a meeting at which a quorum was present with a vote of 2,209.70 FOR; <u>-0-</u> AGAINST;
27	198.70[04] NOT VOTING; and 187.10[05] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by
28 29	the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
30	Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
31	18, 1934 (48 Stat. 984).
