

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Tohono O'odham Nation's "2010 Indian Housing Plan")

RESOLUTION NO. 10-256

1 **WHEREAS, Article VI, Section 1(c)(2) of the Constitution of the Tohono O'odham Nation vests the**
2 **Legislative Council with the power to enact laws "to promote, protect and provide for**
3 **public health, peace, morals, education and general welfare of the Tohono O'odham**
4 **Nation and its members"; and**

5 **WHEREAS, the Tohono O'odham Ki:Ki Association ("TOKA") is the Nation's tribally designated**
6 **housing entity in accordance with the Native American Housing Assistance and Self-**
7 **Determination Act of 1996, 25 U.S.C. §4101, et seq., P.L. 104-330, 110 Stat. 4016**
8 **("NAHASDA"); and**

9 **WHEREAS, to qualify for funds from the Indian Housing Block Grant Program, the NAHASDA**
10 **requires submission of an annual Indian Housing Plan ("IHP") by the Indian tribe or**
11 **by the tribe's designated housing entity (25 U.S.C. 4112); and**

12 **WHEREAS, under the Nation's TOKA Ordinance, the TOKA is responsible for updating, preparing,**
13 **and implementing the Nation's annual Indian Housing Plan (Ordinance No. 98-03, as**
14 **amended, Article I, 1, Article VII, 1, i); and**

15 **WHEREAS, 25 U.S.C. §4112 (c) provides that the annual IHP "may be prepared and submitted on**
16 **behalf of the tribe by the tribally designated housing entity for the tribe, but only if**
17 **such plan contains a certification by the recognized tribal government of the grant**
18 **beneficiary that such tribe- (1) has had an opportunity to review the plan and has**
19 **authorized the submission of the plan by the housing entity. . ."; and**

20 **WHEREAS, the TOKA has presented the "2010 Indian Housing Plan," for the program year**
21 **beginning July 1, 2010 and ending June 30, 2011 to the Housing Committee for review**
22 **and the Legislative Council for review and approval.**

23 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it approves**
24 **the Nation's "2010 Indian Housing Plan"; provided that any amendments are subject**
25 **to Legislative Council review and approval.**

26 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes**
27 **the TOKA to submit the 2010 Indian Housing Plan to the Southwest Area Office of**
28 **Native American Programs to meet the regulatory deadline of July 1, 2010 in**
29 **accordance with 25 U.S.C. 4112 and 24 C.F.R. Part 1000, Subpart C.**

30 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes the**
31 **Nation's Chairperson to sign the certification authorizing submission by the TOKA of**
32 **the 2010 Indian Housing Plan.**
