

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointing Agnes Joaquin to the Election Board for a Five-Year Term Ending
July 31, 2011)**

RESOLUTION NO. 10-260

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "provide for,**
2 **appoint, or provide for the appointment of, and prescribe the duties and powers of**
3 **committees, boards, officers and agents (Article VI, Section 1(b) Constitution of the**
4 **Tohono O'odham Nation); and**

5 **WHEREAS, under Ordinance No. 03-86, the Uniform Election Ordinance ("Election Ordinance")**
6 **authorizes the Tohono O'odham Legislative Council to appoint members of the**
7 **Tohono O'odham Election Board (Election Ordinance, Article II, Section 1(B)); and**

8 **WHEREAS, the Election Ordinance provides that board members shall be "appointed... for terms**
9 **of five years, or until their successors are appointed and qualified" and further "that**
10 **appointments to the board shall be made in such a way and for such terms that their**
11 **terms shall be staggered so that the term of office of only one member will end in any**
12 **single year." (Election Ordinance, Article II, Section 1(B)); and**

13 **WHEREAS, Nicholas Lewis was appointed to the Election Board by Resolution No. 06-768 for a term**
14 **ending July 31, 2011, however he has since resigned and created a vacancy on the**
15 **Election Board; and**

16 **WHEREAS, the Rules Committee having legislative oversight over the Election Board has solicited**
17 **and interviewed qualified bilingual members of the Nation to serve on the Election**
18 **Board; and**

19 **WHEREAS, the Rules Committee recommends that Agnes Joaquin be appointed to the Election**
20 **Board for a term ending July 31, 2011.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
22 **the appointment of Agnes Joaquin to the Election Board beginning on the effective**
23 **date of this resolution and ending July 31, 2011; provided that she shall continue to**
24 **serve until replaced by a successor who has been appointed and qualified.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH Day**
26 **of JULY, 2010 at a meeting at which a quorum was present with a vote of 2,169.50 FOR; 426.0**
27 **AGAINST; -02- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
28 **Article VI, Section 1 (b) and Article X, Section 7 of the Constitution of the Tohono O'odham Nation,**
29 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
30 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act**
31 **of June 18, 1934 (48 Stat. 984).**
