RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Appointing Agnes Joaquin to the Election Board for a Five-Year Term Ending July 31, 2011)

RESOLUTION NO. 10-260

WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "provide for
appoint, or provide for the appointment of, and prescribe the duties and powers of
committees, boards, officers and agents (Article VI, Section 1(b) Constitution of the
Tohono O'odham Nation); and
WHEREAS, under Ordinance No. 03-86, the Uniform Election Ordinance ("Election Ordinance")
authorizes the Tohono O'odham Legislative Council to appoint members of the
Tohono O'odham Election Board (Election Ordinance, Article II, Section 1(B)); and
WHEREAS, the Election Ordinance provides that board members shall be "appointed \dots for terms
of five years, or until their successors are appointed and qualified" and further "that
appointments to the board shall be made in such a way and for such terms that their
terms shall be staggered so that the term of office of only one member will end in any
single year." (Election Ordinance, Article II, Section 1(B)); and
WHEREAS, Nicholas Lewis was appointed to the Election Board by Resolution No. 06-768 for a term
ending July 31, 2011, however he has since resigned and created a vacancy on the
Election Board; and
WHEREAS, the Rules Committee having legislative over sight over the Election Board has solicited
and interviewed qualified bilingual members of the Nation to serve on the Election
Board; and
WHEREAS, the Rules Committee recommends that Agnes Joaqin be appointed to the Election
Board for a term ending July 31, 2011.
NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
the appointment of Agnes Joaquin to the Election Board beginning on the effective
date of this resolution and ending July 31, 2011; provided that she shall continue to
serve until replaced by a successor who has been appointed and qualified.
The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12^{TH} Day of <u>[ULY, 2010]</u> at a meeting at which a quorum was present with a vote of <u>2,169.50</u> FOR; <u>426.0</u>
AGAINST; <u>-02-</u> NOT VOTING; and <u>[01]</u> ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1 (b) and Article X, Section 7 of the Constitution of the Tohono O'odham Nation,
adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy
Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
