

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Sanitation Facilities Deficiency System Priority Ranking)**

RESOLUTION NO. 10-263

1 WHEREAS, Indian Health Service, Division of Environmental Health and Engineering (DEH&E)
2 conducts an assessment of Sanitation Facilities Deficiencies, annually; and

3 WHEREAS, the Division of Environmental Health and Engineering assessment does have an
4 impact upon congressional appropriations and IHS allocation of funds; and

5 WHEREAS, Indian Health Service has provided for Tribal Priority ranking of the four (4) most
6 critical projects and does allocate points impacting upon overall prioritization of
7 projects; and

8 WHEREAS, the Division of Environmental Health and Engineering has provided
9 recommendations to the Tohono O'odham Legislative Council regarding the most
10 critical needs.

11 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council has reviewed
12 and approved the entire priority list and has determined the following deficiencies are
13 the four most critical and desirable, in descending order of prioritization:

- 14 1. Cowlic Lagoon Expansion
- 15 2. N. Santa Rosa/Boarding School Sewer Intertic
- 16 3. Charco 27 Water & Sewer
- 17 4. San Luis/Pablo Verde Stand Water & Sewer

18 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day
19 of JULY, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;
20 -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI,
21 Section 1 (j) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham
22 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs
23 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
