| 9        | agreement that covers reclamation of the Mission Complex Mining and Business  |
| 10       | Leases; and   |
| 11       | WHEREAS, significant progress has been made on the reclamation of the Mission Complex Mining                            |
| 12       | and Business Leases; and  |
| 13       | WHEREAS, the San Xavier District and the allottees of the Mission Complex Mining and Business                           |
| 14       | Leases have taken the position that the ASARCO land exchange study required under                                       |
| 15       | AWSA is no longer needed or wanted.   |
| 16       | NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council finds that a                                   |
| 17       | feasibility study for a potential land exchange at the ASARCO mine site is no longer                                    |
