

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Appointment of Ms. Christina Andrews to the Tohono O'odham
Gaming Enterprise Management Board)**

RESOLUTION NO. 10-267

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "provide for,**
2 **appoint, or provide for the appointment of, and prescribe the duties and powers of**
3 **committees, boards, officers and agents (Article VI, Section 1(b) Constitution of the**
4 **Tohono O'odham Nation); and**

5 **WHEREAS, the Legislative Council has enacted and subsequently amended the "Charter of the**
6 **Tohono O'odham Gaming Enterprise," which established a Management Board**
7 **("Board") consisting of seven Directors who exercise general authority and**
8 **responsibility for the management and operation of the Gaming Enterprise (Section**
9 **5(d)(1)); and**

10 **WHEREAS, Directors shall be appointed for terms of three years or until their successors are**
11 **appointed and qualified (Charter, Section 5(a)(4)); and**

12 **WHEREAS, the Chairman of the Nation shall appoint Directors to the Tohono O'odham Gaming**
13 **Enterprise Management Board with the approval of the Legislative Council (Charter,**
14 **Section 5(a)(2)); and**

15 **WHEREAS, Mr. George Steele was appointed by Resolution No. 03-066 for a term expiring**
16 **September 30, 2005 and he continues to serve until his successor is appointed; and**

17 **WHEREAS, the Chairman of the Tohono O'odham Nation has determined that Ms. Christina**
18 **Andrews is qualified to serve on the Board and will replace Mr. George Steele for a**
19 **term expiring September 30, 2011; and**

20 **WHEREAS, the Legislative Commerce and Rules Committees have reviewed the Chairman's**
21 **appointment.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
23 **the appointment of Ms. Christina Andrews to the Tohono O'odham Gaming Enterprise**
24 **Management Board for a three-year term beginning on the effective date of this**
25 **resolution and ending on September 30, 2011, provided that she shall continue to**
26 **serve until her successor has been appointed and qualified.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH Day**
28 **of JULY, 2010 at a meeting at which a quorum was present with a vote of 2,260.45 FOR; 335.05**
29 **AGAINST; ~~-01-~~ NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
30 **Article VI, Section 1 (b) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
31 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
32 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
33 **Stat. 984).**
