

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Federal Emergency Management Agency (FEMA) – Tribal Agreement for  
the Major Disaster Declaration FEMA-1888-DR-AZ)**

**RESOLUTION NO. 10-272**

1 **WHEREAS, the winter storm of January 2010 that occurred during the period of January 18 – 22,**  
2 **2010 caused significant damages on the Tohono O'odham Nation and required the**  
3 **efforts of many agencies and individuals to assist in response and recovery efforts**  
4 **through a disaster declaration by the Chairman of the Nation; and**

5 **WHEREAS, due to the extent of the storm damages that occurred during that timeframe**  
6 **throughout the State of Arizona and the subsequent response and recovery efforts**  
7 **throughout the state during and since the incident, the Governor of Arizona signed a**  
8 **state declaration on January 21, 2010 which was amended on February 11, 2010 to**  
9 **include the recognized impacts on the Tohono O'odham Nation; and**

10 **WHEREAS, after careful review and assessments by the Federal Emergency Management Agency**  
11 **(FEMA), on March 18, 2010, the President of the United States declared that a major**  
12 **disaster exists in the State of Arizona to include the Tohono O'odham Nation under**  
13 **FEMA-1888-DR-AZ; and**

14 **WHEREAS, through direct government to government relationships, the Tohono O'odham Nation**  
15 **Office of Emergency Management began working directly with FEMA representatives**  
16 **to assess damages and response efforts; and**

17 **WHEREAS, upon completion of the required assessments, the Tohono O'odham Nation will be**  
18 **eligible to receive reimbursement for costs incurred as well as received funds to**  
19 **mitigate or fix other property or infrastructure projects that have yet to be completed;**  
20 **and**

21 **WHEREAS, in order to accept these funds the Tohono O'odham Nation is required to sign a FEMA**  
22 **– Tribal Agreement; and**

23 **WHEREAS, the FEMA – Tribal Agreement and subsequent documents have been reviewed and**  
24 **approved by the Office of Grants and Contracts, Executive Office, Domestic Affairs**  
25 **Committee, and the aforementioned offices and committees recommend approval by**  
26 **the Legislative Council.**

27 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
28 **Federal Emergency Management Agency (FEMA) – Tribal Agreement substantially in**  
29 **the form attached hereto and authorizes the Chairman of the Nation to execute it.**

BE IT FINALLY RESOLVED that upon completion of FEMA assessments, the Tohono O'odham Nation Office of Emergency Management will bring forward the funding amounts to the Tohono O'odham Legislative Council for approval.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15<sup>TH</sup> Day of JULY, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1 (c)(6) & 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


