

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving an Intergovernmental Agreement (IGA) FTF-RC026-10-0206-01 with the  
Arizona Early Childhood Development and Health Board (First Things First) and  
the Tohono O'odham Nation)**

**RESOLUTION NO. 10-273**

1 **WHEREAS, the Tohono O'odham Nation recognizes and prioritizes the importance of education**  
2 **and development of the children of the Nation; and**

3 **WHEREAS the First Things First initiative was passed by Arizona Voters in 2006 via proposition**  
4 **203 which increases the quality and access to early childhood programs that will**  
5 **ensure all Arizona children enter school healthy and ready to learn; and**

6 **WHEREAS, the Tohono O'odham Nation recognizes specific areas of need in Head Start, Child**  
7 **Care and Division of Special Needs for which funding may be allocated to the Nation**  
8 **through the proposed Intergovernmental Agreement with the First Things First**  
9 **organization; and**

10 **WHEREAS, the First Things First Intergovernmental Agreement which shall commence**  
11 **September 1, 2009 and be renewed for two additional twelve month periods based on**  
12 **performance and availability of funds; and**

13 **WHEREAS, the Human Resources Development, Health & Human Services and Domestic Affairs**  
14 **Committees of the Legislative Council have reviewed the First Things First**  
15 **Intergovernmental Agreement FTF-RC026-10-0206-01.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
17 **accept, approve, and authorize the First Things First Intergovernmental Agreement**  
18 **which shall commence September 1, 2009 and be renewed for two additional twelve**  
19 **month periods based on performance and availability of funds.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Chairman of the**  
21 **Nation is hereby authorized to sign and execute the First Things First**  
22 **Intergovernmental Agreement FTF-RC026-10-0206-01, provided however, that any**  
23 **amendments affecting the funds or funding levels of the grant shall be submitted for**  
24 **further prior approval.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15<sup>TH</sup> Day**  
26 **of JULY, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**  
27 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI,**  
28 **Section 1 (d)(2) and (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
29 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
30 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
31 **Stat. 984).**




