

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Endorsing Re-election of State Representative Patricia Fleming for Legislative
District 25 Representative)**

RESOLUTION NO. 10-274

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with the**
2 **authority to consult with state and local governments and to "promote, protect and**
3 **provide for public health, peace, morals, education and general welfare of the**
4 **Tohono O'odham Nation and its members" (Constitution, Article VI, Section 1 (c)(2));**
5 **and**

6 **WHEREAS, in November 2010, the State of Arizona will hold an election to elect candidates to the**
7 **Arizona State Legislature; and**

8 **WHEREAS, Representative Patricia Fleming has served Legislative District 25 in the Arizona State**
9 **Legislature since January 2009; and**

10 **WHEREAS, Representative Patricia Fleming recognizes and supports the unique trust**
11 **relationship between the United States of America and sovereign Native American**
12 **tribes such as the Tohono O'odham Nation; and**

13 **WHEREAS, Representative Patricia Fleming understands the importance and benefit of an**
14 **effective and productive state-tribal relationship; and**

15 **WHEREAS, during the July general session, Representative Patricia Fleming presented**
16 **information to and answered questions from the Tohono O'odham Legislative**
17 **Council about her re-election campaign; and**

18 **WHEREAS, although the Tohono O'odham Legislative Council endorses and supports**
19 **Representative Patricia Fleming's re-election for Legislative District 25**
20 **representative, the Council also encourages the Nation's members to vote as they**
21 **deem appropriate.**

22 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
23 **endorses and supports Representative Patricia Fleming's re-election for Legislative**
24 **District 25 representative.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH Day**
26 **of JULY, 2010 at a meeting at which a quorum was present with a vote of 1,962.0 FOR; -0- AGAINST;**
27 **230.10 [01] NOT VOTING; and 403.40 [08] ABSENT, pursuant to the powers vested in the Council by**
28 **Section 1 (c)(2) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the**
29 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat. 984).**
