

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Resolution Number 10-156, Accepting Certification of Eligible Members  
and Authorizing the Initial Expenditure of Funds for Per Capita Payments under  
the Second Per Capita Plan)**

**RESOLUTION NO. 10-282**

1 **WHEREAS, the Tohono O'odham Legislative Council enacted Resolution No. 10-156 on May 13,**  
2 **2010, accepting certification of eligible members and authorizing the initial**  
3 **expenditure of funds for per capita payments under the second per capita plan; and**

4 **WHEREAS, the second resolve clause authorized Wells Fargo Bank to commence payments of**  
5 **principal and investment income to identified eligible members; and**

6 **WHEREAS, the list of identified members erroneously included three adult members that should**  
7 **be paid from the Per Capita #2 checking account at Bank of America.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
9 **Authorizes the Accounting Office to commence payments from the Bank of America**  
10 **Per Capita #2 checking account to the three adult eligible members initially identified**  
11 **in Resolution No. 10-156 and attached hereto.**

12 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup> Day**  
13 **of JULY, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**  
14 **-02- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI,**  
15 **Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
16 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
17 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
18 **Stat. 984).**
