

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution Number 10-189, Accepting Certification of Eligible Members and
Authorizing the Initial Expenditure of Funds for Per Capita Payments under the Initiative)**

RESOLUTION NO. 10-283

1 WHEREAS, the Tohono O'odham Legislative Council enacted Resolution No. 10-189 on June 8,
2 2010, accepting certification of eligible members and authorizing the initial
3 expenditure of funds for per capita payments under the Initiative; and
4 WHEREAS, the second resolve clause authorized Wells Fargo Bank to commence payments of
5 principal and investment income to identified eligible members; and
6 WHEREAS, the list of identified members erroneously included one adult member that should be
7 paid from the Initiative checking account at Bank of America.
8 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby
9 authorizes the Accounting Office to commence payment from the Bank of America
10 Initiative checking account to the one adult eligible member initially identified in
11 Resolution No. 10-189 and attached hereto.

12 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH Day
13 of JULY, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;
14 -01- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI,
15 Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
16 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
17 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
18 Stat. 984).


