

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appropriating Desert Diamond Savings to Supplement the FY 2011 Gaming
Distribution to the Districts in the amount of \$5,500,896.00)**

RESOLUTION NO. 10-289

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power "to manage any**
2 **funds within the exclusive control of the Tohono O'odham Nation" (Constitution of the**
3 **Tohono O'odham Nation, Article VI, Section 1(d)(2)); and**

4 **WHEREAS, pursuant to Tohono O'odham Legislative Council Resolution No. 09-265, the Nation**
5 **funded the shortfall for the Districts in the amount of \$5,500,896.00 from Desert**
6 **Diamond Savings; and**

7 **WHEREAS, the Nation's Treasurer has determined that the District's continue to face a shortfall**
8 **for FY 2011 and recommends to the Legislative Budget and Finance Committee and the**
9 **Executive Office that the Nation match the FY 2010 economic recovery plan; and**

10 **WHEREAS, the Legislative Budget and Finance Committee and the Executive Office recommend**
11 **the use of Desert Diamond Savings of \$5,500,896.00 as an economic recovery plan for**
12 **the Districts during this time of negative economic conditions.**

13 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
14 **appropriates \$5,500,896.00 to supplement the FY 2011 Gaming Distribution to the**
15 **Districts for the purpose of funding the FY2011 District budgets.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27TH Day**
17 **of JULY, 2010 at a meeting at which a quorum was present with a vote of 2,230.20 FOR; 365.30**
18 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article**
19 **VI, Section 1 (d) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
20 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
21 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
22 **Stat. 984).**
