4	WHEREAS, pursuant to Tohono O'odham Legislative Council Resolution No. 09-265, the Nation							
5	funded the shortfall for the Districts in the amount of \$5,500,896.00 from Desert							
6	Diamond Savings; and							
7	WHEREAS, the Nation's Treasurer has determined that the District's continue to face a shortfall							
8	for FY 2011 and recommends to the Legislative Budget and Finance Committee and the							
9	Executive Office that the Nation match the FY 2010 economic recovery plan; and							
10	WHEREAS, the Legislative Budget and Finance Committee and the Executive Office recommend							
11	the use of Desert Diamond Savings of \$5,500,896.00 as an economic recovery plan for							
12	the Districts during this time of negative economic conditions.							
13	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby							
14	appropriates \$5,500,896.00 to supplement the FY 2011 Gaming Distribution to the							
15	Districts for the purpose of funding the FY2011 District budgets.
