## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Approving the Fiscal Year 2011 Budget for the Tohono O'odham Nation Justice Center and Appropriating Funds in the Amount of \$5,674,993.72)

1	WHEREAS, the Fiscal Year ("FY") 2010 will end at midnight, September 30, 2010 and all spending
2	authority granted under the FY 2010 budgets will terminate at that time; and
3	WHEREAS, the Judicial Branch of the Tohono O'odham Nation has prepared and presented a
4	budget to the Tohono O'odham Legislative Council ("Legislative Council") that reflects
5	the needs of the Branch for the 2011 fiscal year, a copy of the proposed said budget is
6	attached hereto and incorporated herein by reference; and
7	WHEREAS, the proposed FY 2011 Judicial Branch budget includes employee salaries in the
8	amount of \$3,710,642.00, other compensation at \$152,450.42, fringe benefits at 32.5%
9	in the amount of \$1,255,505.04, and operational costs in the amount of \$556,396.26,
10	totaling \$5,674,993.72 for FY 2011; and
11	WHEREAS, the Judiciary Committee and the Budget and Finance Committee of the Legislative
12	Council have reviewed this budget and recommend its approval and adoption.
13	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council has reviewed
14	and approves the Fiscal Year 2011 budget for the Tohono O'odham Judicial Branch in
15	the amount of \$5,674,993.72.
16	BE IT FURTHER RESOLVED that funds in the amount of \$5,674,993.72 is appropriated from the
17	general funds and authorized to be expended for the Fiscal Year 2011 budget of the
18	Tohono O'odham Judicial Branch.
19	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council does hereby authorize the
20	Chief Judge and any designated official to expend and administer the budget as
21	attached, provided that any amendments affecting the funds or funding level shall be
22	submitted for further prior approval by the Tohono O'odham Legislative Council.
