

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving and Appropriating Legislative Branch FY 2011 Budget in the amount of \$3,269,563.62)

RESOLUTION NO. 10-293

1 WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with the
2 authority "to manage any funds within the exclusive control of the Tohono O'odham
3 Nation. . . and to appropriate these funds for the benefit of the Nation and its
4 members" "provided that" [a]ll expenditures of these funds shall be pursuant to
5 appropriations or budgets" authorized by resolution or ordinance (Constitution of the
6 Tohono O'odham Nation, Article VI, section 1(d)(2)); and

7 WHEREAS, the Legislative Branch has prepared and submitted for review and approval of its FY
8 2011 Legislative Branch Budget, which is incorporated by this reference; and

9 WHEREAS, the Budget and Finance Committee and the Legislative Council have reviewed the FY
10 2011 Legislative Branch Budget.

11 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby
12 appropriates and authorizes expenditure of the FY 2011 Legislative Branch in the
13 amount of \$3,269,563.62, as per the attached budget, beginning October 1, 2010 and
14 ending September 30, 2011.

15 BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council does hereby authorize the
16 Chairperson and any designated official to expend and administer the budget as
17 attached, provided that any amendments affecting the funds or funding level shall be
18 submitted for further prior approval by the Tohono O'odham Legislative Council.

19 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27TH Day
20 of JULY, 2010 at a meeting at which a quorum was present with a vote of 1,947.20 FOR; 449.60
21 AGAINST; -01- NOT VOTING; and 198.70[06] ABSENT, pursuant to the powers vested in the Council
22 by Article VI, Section 1 (d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the
23 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
24 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
25 18, 1934 (48 Stat. 984).
