

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Adopting and Approving the Executive Branch Fiscal Year 2011 Tribal Budget and  
Appropriating the Amount of \$63,316,394.06)**

RESOLUTION NO. 10-295

1 **WHEREAS, the Executive Branch has prepared and presented its fiscal year 2011 tribal budgets**  
2 **to the Tohono O'odham Legislative Council; and**

3 **WHEREAS, the Executive Branch Fiscal Year 2011 Budget for the period beginning October 01,**  
4 **2010 ending September 30,2011 has been presented to the Legislative Council both in**  
5 **summary as Schedule 1 as well as in detailed budgets (collectively. "Executive Branch**  
6 **FY 2011 Budget") that by this reference are all incorporated into this Resolution.**

7 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council does hereby adopt, approve and**  
8 **appropriates \$63,316,394.06 from general fund revenues to fund the Executive Branch**  
9 **Fiscal Year 2011 Budget.**

10 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes**  
11 **the expenditure of funds appropriated to and in accordance with the Executive Branch**  
12 **FY 2011 Budget for the period beginning October 01, 2010 ending September 30, 2011**  
13 **and are attached hereto.**

14 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
15 **Chairman, Vice Chairman and any designated official are authorized to administer**  
16 **the Executive Branch FY 2011 Budget, provided however that any amendments**  
17 **affecting the aggregate total of the funds originally budgeted for the purposes for**  
18 **which the funds were budgeted shall be submitted for prior approval by the Tohono**  
19 **O'odham Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 29<sup>TH</sup> Day**  
21 **of JULY, 2010 at a meeting at which a quorum was present with a vote of 2,214.95 FOR;181.85**  
22 **AGAINST; -0- NOT VOTING; and 198.70[07] ABSENT, pursuant to the powers vested in the Council**  
23 **by Article VI, Section 1 (d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**  
24 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
26 **18, 1934 (48 Stat. 984).**
