5	summary as Schedule 1 as well as in detailed budgets (collectively. "Executive Branch
6	FY 2011 Budget") that by this reference are all incorporated into this Resolution.
7	NOW, THEREFORE, BE IT RESOLVED that the Legislative Council does hereby adopt, approve and
8	appropriates \$63,316,394.06from general fund revenues to fund the Executive Branch
9	Fiscal Year 2011 Budget.
10	BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes
11	the expenditure of funds appropriated to and in accordance with the Executive Branch
12	FY 2011 Budget for the period beginning October 01, 2010 ending September 30, 2011
13	and are attached hereto.
14	BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
15	Chairman, Vice Chairman and any designated official are authorized to administer
16	the Executive Branch FY 2011 Budget, provided however that any amendments
17	affecting the aggregate total of the funds originally budgeted for the purposes for
18	which the funds were budgeted shall be submitted for prior approval by the Tohono
19	O'odham Legislative Council.
