

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval and Acceptance of the Application of the FY2011 Grant Award USEPA**  
**General Assistance Program (GAP ))**

RESOLUTION NO. 10-301

1 WHEREAS, Tohono O'odham Legislative Council accepted \$365,000.00 in new funding for the  
2 continuation of the General Assistance Program (GAP) on October 19, 2009 by  
3 Resolution No. 09-544; and

4 WHEREAS, the GAP Grant is a 4-year continuation grant with a project period that extends from  
5 October 1, 2009 through September 30, 2013 which requires annual applications for  
6 new funding; and

7 WHEREAS, the Tohono O'odham Nation submitted a proposal to the US Environmental Protection  
8 Agency in the amount of \$335,867.00 for the General Assistance Program for FY2011;  
9 and

10 WHEREAS, the US Environmental Protection Agency has allocated \$335,867.00; and

11 WHEREAS, the US Environmental Protection Agency has requested that Indirect Costs not be  
12 included until the Indirect Cost Agreement has been approved; and

13 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts  
14 the award amount of \$335,867.00 of new funding for the continuation of the GAP Grant.

15 BE IT FURTHER RESOLVED that Indirect Costs are not included in this budget until the Indirect  
16 Cost Agreement has been approved.

17 BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council approves the attached  
18 budget and authorizes the expenditure of funds according to this budget, which shall  
19 be in effect from October 1, 2010 to September 30, 2011.

20 BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the  
21 Chairperson and any designated official to expend and administer the budget as  
22 attached, provided that any amendments affecting the funds or funding level shall be  
23 submitted for further prior approval by the Tohono O'odham Legislative Council.

24 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 29<sup>TH</sup> Day  
25 of JULY, 2010 at a meeting at which a quorum was present with a vote of 2,408.40 FOR; -0- AGAINST;  
26 187.10 [01] NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article  
27 VI, Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono  
28 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
29 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
30 Stat. 984).
