

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving and Authorizing KOHN's FY 2011 CPB CSG Budget, in the amount of  
\$197,821.06 and Waiver of Indirect Costs)**

**RESOLUTION NO. 10-304**

1 **WHEREAS, KOHN 91.9 FM was licensed to begin broadcast on December 23, 2005 and completed**  
2 **its first year of on-air broadcast on December 23, 2006, thereby becoming eligible for**  
3 **a Community Service Grant (CSG) from the Corporation for Public Broadcasting (CPB);**  
4 **and**

5 **WHEREAS, the CSG is a single grant program consisting of several levels of qualification, each**  
6 **level having specific requirements that determine the amount of funding that an**  
7 **eligible grantee will be awarded. CPB determines the appropriate CSG funding level**  
8 **based on the information provided by the applicant; and**

9 **WHEREAS, the CPB requires that all applicants spent approximately 27% of CSG funding on costs**  
10 **relating to the acquisition or production of national programming; and**

11 **WHEREAS, CSG funding is restricted to operational support of radio broadcast operations and**  
12 **does not provide for administrative cost rates normally applied to grants as indirect**  
13 **cost, therefore making it necessary that the established indirect cost rate of the nation**  
14 **be waived for this grant; and**

15 **WHEREAS, the Tohono O'odham Nation has received notice from CPB that KOHN will continue to**  
16 **be funded at similar levels for succeeding fiscal years so long as it maintains its**  
17 **eligibility; and**

18 **WHEREAS, each grant award has an expenditure period of two years, the 2011 grant amount will**  
19 **have a grant period of October 1, 2010 through September 30, 2012, however, KOHN**  
20 **budgets the full amount for the current fiscal year of October 1, 2010 through**  
21 **September 30, 2011 and intends to re-submit to the legislative council for approval the**  
22 **carry forward of any funding that remains unexpended at fiscal year-end 2011; and**

23 **WHEREAS, KOHN has prepared and submitted for internal review by the Executive Branch,**  
24 **Cultural Preservation Committee and the Budget and Finance Committee the**  
25 **attached budget, in the amount of \$197,821.06, to facilitate the expenditure of the**  
26 **grant.**

27 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
28 **the waiver of Indirect Costs as required of the grant.**

29 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the attached budget,**  
30 **in the amount of \$197,821.06, is approved and authorized to be expended for the**  
31 **purposes described effective fiscal year October 1, 2010 through September 30, 2011.**

1 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham  
2 Nation's Officials to-wit: the Chairman, and any designated official, are authorized  
3 to execute the grant, provided however, that any amendments affecting the funds or  
4 funding levels of the grant shall be submitted for further prior approval by the Tohono  
5 O'odham Legislative Council.

6 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 29<sup>TH</sup> Day  
7 of JULY, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;  
8 -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article VI,  
9 Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham  
10 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
11 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
