

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Tohono O'odham Department of Health and Human Services -
Division of Behavioral Health FY2011 Third Party Revenue Budget -
Account No. 18-1429)

RESOLUTION NO. 10-309

1 **WHEREAS, the Department of Health and Human Services, Division of Behavioral Health is**
2 **currently operating the Behavioral Health Division through an Indian Health Services**
3 **(I.H.S.) 638 Contract. The Seriously Mentally Ill (SMI) Program is a comprehensive Day**
4 **Treatment Program for Seriously Mentally Ill and Developmental Disabled Adults,**
5 **services which includes educational sessions on general mental health and substance**
6 **abuse, community activities, work projects, and case management. The original SMI**
7 **funds from the I.H.S. grant ended on August 31, 1990; and**

8 **WHEREAS, pursuant to Legislative Council Resolution No. 99-500, the Department of Health and**
9 **Human Services, Division of Behavioral Health, SMI Program has been collecting third**
10 **party reimbursement funds since September 1999 from the State of Arizona and has**
11 **since accumulated funds; and**

12 **WHEREAS, the Division of Behavioral Health, has accumulated funds to cover the Third Party**
13 **Revenue Budget Account No. 18-1429 in the amount of \$304,524.69 for FY2011**
14 **personnel and operational expenses (October, 01 2010 to September 30, 2011); and**

15 **WHEREAS, the Department of Health and Human Services, Behavioral Health Division request to**
16 **continue to cost share the Project Administrator position at 25% or \$14,770.04 and**
17 **fringe benefits to reflect the salary from October 1, 2010 to September 30, 2011. Cost**
18 **share with MOH 50% and HOPP 25% to work and complete any future projects as**
19 **needed for the development of services provided to the Nation; and**

20 **WHEREAS, a Third Party Revenue budget in the amount of \$304,524.69 for FY2011, has been**
21 **submitted for review and approval by the Department of Health and Human Services,**
22 **Division of Behavioral Health.**

23 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 24 **1. The attached FY2011 Third Party Revenue Budget in the amount of \$304,524.69 to**
25 **supplement the FY2011 Department of Health and Human Services, Division of**
26 **Behavioral Health Budget is hereby approved to expend such funds in an amount**
27 **not to exceed \$304,524.69 to supplement the Division of Behavioral Health FY2011**
28 **budgets.**
- 29 **2. Approve to continue to cost share the Project Administrator position at 25% or**
30 **\$14,770.04 and fringe benefits to reflect the salary from October 1, 2010 to**
31 **September 30, 2011. Cost share with MOH 50% and HOPP 25% to work and**



2 **to the Nation.**


3 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
4 **Chairperson and any designated official to expend and administer the budget as**
5 **attached, provided that any amendments affecting the funds or funding level shall be**
6 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

7 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30TH Day**
8 **of JULY, 2010 at a meeting at which a quorum was present with a vote of 2,408.40 FOR; -0- AGAINST;**
9 **187.10 [01] NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by Article**
10 **VI, Section 1 (d)(2) and (f) of the Constitution of the Tohono O'odham Nation, adopted by the**
11 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
12 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
13 **18, 1934 (48 Stat. 984).**
