3	reimbursements where applicable; and
4	WHEREAS, the Tohono O'odham Legislative Council Resolution No. 2000-258 approved all third
5	party reimbursement funds collected by the Division of Health Transportation Service
6	be applied to the program's base budget for program operations; and
7	WHEREAS, there is a need to supplement the FY 2011 Tribal budget with FY 2010 Third Party
8	Revenue funds in the amount of \$2,609,716.42 for operational costs of the Division of
9	Health Transportation Service; and
10	WHEREAS, the Division of Health Transportation Service has sufficient funds deposited with the
11	Nation's Accounting Department to cover the proposed budget amount of
12	\$2,609,716.42; and
13	WHEREAS, a Third Party Revenue budget, in the amount of \$2,609,716.42 for FY 2011, has been
14	submitted for review and approval by the Department of Health and Human Services
15	for the Division of Health Transportation Service.
16	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
17	the attached FY 2011 Third Party Revenue Budget in the amount of \$2,609,716.42 to
18	supplement the FY 2011 Health Transportation Service Budget.
19	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
20	Chairperson and any designated official to expend and administer the budget as
21	attached, provided that any amendments affecting the funds or funding level shall be
22	submitted for further prior approval by the Tohono O'odham Legislative Council.
