

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the FY 2011 Department of Health and Human Services - Division of
Health Transportation Service Third Party Budget Account #18-1458)**

RESOLUTION NO. 10-310

1 **WHEREAS, the Tohono O'odham Nation continues to provide non-emergency medically necessary**
2 **transportation to members and residents of the Nation, collecting third party**
3 **reimbursements where applicable; and**

4 **WHEREAS, the Tohono O'odham Legislative Council Resolution No. 2000-258 approved all third**
5 **party reimbursement funds collected by the Division of Health Transportation Service**
6 **be applied to the program's base budget for program operations; and**

7 **WHEREAS, there is a need to supplement the FY 2011 Tribal budget with FY 2010 Third Party**
8 **Revenue funds in the amount of \$2,609,716.42 for operational costs of the Division of**
9 **Health Transportation Service; and**

10 **WHEREAS, the Division of Health Transportation Service has sufficient funds deposited with the**
11 **Nation's Accounting Department to cover the proposed budget amount of**
12 **\$2,609,716.42; and**

13 **WHEREAS, a Third Party Revenue budget, in the amount of \$2,609,716.42 for FY 2011, has been**
14 **submitted for review and approval by the Department of Health and Human Services**
15 **for the Division of Health Transportation Service.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
17 **the attached FY 2011 Third Party Revenue Budget in the amount of \$2,609,716.42 to**
18 **supplement the FY 2011 Health Transportation Service Budget.**

19 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
20 **Chairperson and any designated official to expend and administer the budget as**
21 **attached, provided that any amendments affecting the funds or funding level shall be**
22 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30TH Day**
24 **of JULY, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**
25 **-0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article VI,**
26 **Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
27 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
28 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
29 **Stat. 984).**
