WHEREAS, the Tohono O'odham Department of Health and Human Services, Family Assistance
Division, Food Distribution Program has submitted the FY2011 Nutrition Education
funding budget in the amount of \$1,800.00 for review and approval.
NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and
authorizes the expenditure of the FY2011 Food Distribution Nutrition Education
budget in the amount of \$1,800.00 in accordance with the attached budget.
BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
Chairperson and any designated official to expend and administer the budget as
attached, provided that any amendments affecting the funds or funding level shall be
submitted for further prior approval by the Tohono O'odham Legislative Council.
The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30 TH Day of JULY, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1 (d)(2)(3) and (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
