RESOLUTION NO. 10-313

1 **WHEREAS, the Department of Health and Human Services, Management of Health Division**
2 **coordinates services provision for its ten divisions; and**

3 **WHEREAS, the Management of Health Division submitted an application to the Office on Violence**
4 **Against Women (OVW) for funding under the Grants to Indian Tribal Governments**
5 **Program in the amount of \$900,000.00 for the next 36 months, for the Tohono**
6 **O'odham Nation; and**

7 **WHEREAS, the Notice of award was received on September 28, 2009 for a three year grant project**
8 **period 10/01/09 - 09/30/12 to implement the program, for sexual assault intervention,**
9 **support services and advocacy to victims of sexual assault; and**

10 **WHEREAS, the Violence Against Women funding for \$900,000.00 will be divided into \$300,000.00**
11 **over the next three years; and**

12 **WHEREAS, a budget of \$300, 0000.00 has been prepared for Fiscal Year 2011.**

13 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council:**

- 14 **1. Accepts, approves and authorizes expenditures in accordance with the Fiscal Year**
15 **2011 attached budget in the amount of \$ 300,000.00.**

16 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
17 **Chairperson and any designated official to expend and administer the budget as**
18 **attached, provided that any amendments affecting the funds or funding level shall be**
19 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30TH Day**
21 **of JULY, 2010 at a meeting at which a quorum was present with a vote of 2,408.40 FOR; -0- AGAINST;**
22 **-0- NOT VOTING; and 187.10[06] ABSENT, pursuant to the powers vested in the Council by Article**
23 **VI, Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
24 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
26 **Stat. 984).**
