

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Consolidated Healthy O'odham Promotion Program FY 2011 Budget  
in the Amount of \$1,929,827.00 October 1, 2010 – September 30, 2011)**

RESOLUTION NO. 10-314

1 WHEREAS, the Tohono O'odham Nation receives a Special Diabetes Programs for Indians grant  
2 through FY 2011 with a base budget of \$1,929,827.00; and

3 WHEREAS, by Resolution Number 99-149, the Tohono O'odham Legislative Council approved the  
4 establishment of the Community Based Diabetes Prevention Program, funded by the  
5 Special Diabetes Programs for Indians, authorized by the Balanced Budget Act of 1997;  
6 and

7 WHEREAS, by Resolution Number 2000-182, the Tohono O'odham Legislative Council approved  
8 the name change of the Community Based Diabetes Prevention Program to the  
9 Healthy O'odham Promotion Program; and

10 WHEREAS, the Tohono O'odham Department of Health and Human Services is requesting the  
11 Fiscal Year 2011 base budget of \$1,929,827.00 remain the same.

12 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and  
13 authorizes the expenditure of the FY 2011 HOPP base budget of \$1,929,827.00.

14 BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the  
15 Chairperson and any designated official to expend and administer the budget as  
16 attached, provided that any amendments affecting the funds or funding level shall be  
17 submitted for further prior approval by the Tohono O'odham Legislative Council.

18 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30<sup>TH</sup> Day  
19 of JULY, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;  
20 -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article VI,  
21 Section 1 (d)(2)(3) and (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono  
22 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
23 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
24 Stat. 984).
