

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Consolidated Healthy O'odham Promotion Program FY 2011 Budget
in the amount of \$397,100.00 October 1, 2010 - September 30, 2011)**

RESOLUTION NO. 10-315

1 WHEREAS, the Tohono O'odham Nation receives a Special Diabetes Programs for Indians
2 Cardiovascular Risk Reduction Demonstration Project grant through FY 2011 with a
3 base budget of \$397,100.00; and

4 WHEREAS, by Resolution Number 99-149, the Tohono O'odham Legislative Council approved the
5 establishment of the Cardiovascular Risk Reduction Demonstration Project, funded
6 by the Special Diabetes Programs for Indians, authorized by the Balanced Budget Act
7 of 1997; and

8 WHEREAS, the Tohono O'odham Department of Health and Human Services is requesting the
9 Fiscal Year 2011 base budget of \$397,100.00 remain the same.

10 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby
11 approves and authorizes the expenditure of the FY 2011 HOPP CVD base budget of
12 \$397,100.00.

13 BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
14 Chairperson and any designated official to expend and administer the budget as
15 attached, provided that any amendments affecting the funds or funding level shall be
16 submitted for further prior approval by the Tohono O'odham Legislative Council.

17 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30TH Day
18 of JULY, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;
19 -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article VI,
20 Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham
21 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs
22 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
