1 **WHEREAS, the Low Income Home Energy Assistance Program (LIHEAP) has been beneficial in**
2 **providing financial assistance to eligible low-income households in meeting utility**
3 **needs, i.e., electricity, propane, water and wood; and**

4 **WHEREAS, the allocation to the Tohono O'odham Nation for FY2011 through the State of Arizona,**
5 **Department of Economic Security, Division of Aging and Adult Services – Community**
6 **Action Program is \$62,572.00; and**

7 **WHEREAS, the Tohono O'odham Nation is hereby submitting the FY2011 budget for funding**
8 **through the State of Arizona, Department of Economic Security, Division of Aging and**
9 **Adult Services – Community Action Program in the amount of \$62,572.00 for contract**
10 **period July 01, 2010 through June 30, 2011; and**

11 **WHEREAS, the Tohono O'odham Department of Health and Human Services, Family Assistance**
12 **Division, Low Income Home Energy Assistance Program has submitted the FY2011 Low**
13 **Income Home Energy Assistance budget in the amount of \$62,572.00 for review and**
14 **approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and**
16 **authorizes the expenditure of the FY2011 Low Income Home Energy Assistance**
17 **Program (LIHEAP) budget in the amount of \$62,572.00 in accordance with the attached**
18 **budget for contract period of July 1, 2010 through June 30, 2011.**

19 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
20 **Chairperson and any designated official to expend and administer the budget as**
21 **attached, provided that any amendments affecting the funds or funding level shall be**
22 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30TH Day**
24 **of JULY, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**
25 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI,**
26 **Section 1 (d)(2)(3) and (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
27 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
28 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
29 **Stat. 984).**
