

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval of the FY 2011 Tohono O'odham Department of Health and Human Services, Division of Community Health – Women, Infants and Children (WIC) – ITCA Program Proposed Budget of \$205,753.00, Account 12-1436)**

RESOLUTION NO. 10-318

1 **WHEREAS, the Tohono O'odham Nation has successfully operated the Tohono O'odham**  
2 **Department of Health and Human Services-Division of Community Health-Women**  
3 **Infants and Children (WIC) Program which provides preventive health care; and**

4 **WHEREAS, the Inter-Tribal Council of Arizona through an Intergovernmental Agreement receives**  
5 **funds from the United States Department of Agriculture for programs designed to**  
6 **benefit women, infants and children; and**

7 **WHEREAS, the Tohono O'odham Nation has entered into a Memorandum of Agreement with the**  
8 **Inter-Tribal Council of Arizona to fund and operate the Women Infants and Children**  
9 **(WIC) Program which commenced on October 01, 2009 through September 30, 2012,**  
10 **which was approved through Resolution Number 10-014; and**

11 **WHEREAS, the services provided to eligible clients have been beneficial and services continue to**  
12 **be necessary to help alleviate nutritional health risks and improve the health of**  
13 **individuals at risk; and**

14 **WHEREAS, the Inter Tribal Council of Arizona is increasing the assigned caseload and grant level**  
15 **for the Women, Infant and Children (WIC) program effective October 1, 2009; and**

16 **WHEREAS, WIC has submitted the FY 2011 WIC Budget and proposal in the amount of \$205,753.00.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
18 **approve and authorize expenditures of the FY 2011 attached budget in the amount of**  
19 **\$205,753.00 from the Inter-Tribal Council of Arizona to continue to operate and**  
20 **provide services to eligible women, infants and children.**

21 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
22 **Chairperson and any designated official to expend and administer the budget as**  
23 **attached provided that any amendments affecting the funds or funding level shall be**  
24 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30<sup>TH</sup> Day**  
26 **of JULY, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**  
27 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI,**  
28 **Section 1 (d)(2)(3) and (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
29 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
30 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
31 **Stat. 984).**
