**(Approval of Arizona Long Term Care Services (ALTCS) Six Month Budget for Fiscal**  
**Year 2011 October 1, 2010 – March 31, 2011 Account: 14-1416)**

**RESOLUTION NO. 10-319**

1 **WHEREAS, the Tohono O'odham Nation has an Intergovernmental Agreement with the State of**  
2 **Arizona to provide Arizona Long Term Care Services (ALTCS) Case Management**  
3 **services to eligible enrolled members; and**

4 **WHEREAS, the Tohono O'odham Nation has provided ALTCS case management services since June**  
5 **1996 and is reimbursed from the State of Arizona for the services; and**

6 **WHEREAS, the fiscal year 2011 six (6) month Arizona Long Term Care Services (ALTCS) Program**  
7 **budget of \$215,256.17 has been prepared in accordance with the Tohono O'odham**  
8 **Nation FY2011 budget instructions; and**

9 **WHEREAS, all Arizona Long Term Care Services (ALTCS) Program reimbursements obtained by**  
10 **the Division of Senior Services; including all savings from previous year budgets shall**  
11 **continue be applied to the Arizona Long Term Care Services (ALTCS) base budget for**  
12 **current operations.**

13 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
14 **approves:**

15 **1. The fiscal year 2011 six (6) month Arizona Long Term Care Services (ALTCS) budget**  
16 **of \$215,256.17 that has been prepared in accordance with the Tohono O'odham**  
17 **Nation FY2011 budget instruction.**

18 **2. That all Arizona Long Term Care Services (ALTCS) Program client reimbursement**  
19 **funds obtained by the Division of Senior Services; including savings from previous**  
20 **year ALTCS budgets continue to be applied to the Arizona Long Term Care Services**  
21 **(ALTCS) Program base budget for current operations.**

22 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
23 **Chairperson and any designated official to expend and administer the budget as**  
24 **attached, provided that any amendments affecting the funds or funding level shall be**  
25 **submitted for further prior approval by the Tohono O'odham Legislature Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30<sup>TH</sup> Day**  
27 **of JULY, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**  
28 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI,**  
29 **Section 1 (d)(2)(3) and (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
30 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
31 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
32 **Stat. 984).**
