4	WHEREAS, Public Health Preparedness and Response for EWIDS is within the charter and
5	mandate as provided by Resolution No. 07-100, affirming the Tohono O'odham
6	Department of Health and Human Services, as the Nation's Public Health authority;

8	WHEREAS, the Tohono O'odham Nation did enter into an Intergovernmental Agreement (IGA),
9	Contract No. HG954111, with the Arizona Department of Health Services (ADHS) for
10	(Public Health) Emergency Preparedness and Response with a start date of August 9,
11	2008 (terminating on August 8, 2013); and
12	WHEREAS, the ADHS IGA, Contract No. HG954111, was approved by the Tohono O'odham
13	Legislative Council by Resolution No. 09-123; and
14	WHEREAS, the ADHS Fiscal Year 2011 EWIDS funding notice was received, and the attached
15	budget prepared in the amount of \$38,911.00.
16	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby:
17	1. Approve the FY 2011 EWIDS budget in the amount of \$38,911.00.
18	2. Authorizes the Nation to obligate and expend funds upon approval of the
19	resolution.
20	BE IT FINALLY RESOLVED that the Tohono O'odham Nation's Legislative Council hereby authorizes
21	the Chairperson and any designated official to expend and administer the budget as
22	attached, provided that any amendments affecting the funds or funding levels shall
23	be submitted for further prior approval by the Tohono O'odham Legislative Council.
