

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval of the FY 2011 Budget for the Tohono O'odham Nation Vocational Rehabilitation Program, Grant Award H250D080009)**

RESOLUTION NO. 10-326

1 WHEREAS, the Tohono O'odham Nation, upon enactment of Resolution No. 08-614, accepted a 5-  
2 year grant, beginning October 1, 2008 to September 30, 2013, from the U.S. Department  
3 of Education, Rehabilitation Services Administration's Section 121 (Vocational  
4 Rehabilitation Service Projects for American Indian with Disabilities) under P.L., 102-  
5 569 Rehabilitation Act of 1973 as amended; and

6 WHEREAS, services under the Tohono O'odham Nation Vocational Rehabilitation Program will  
7 be provided to eligible enrolled members of the Tohono O'odham Nation living on or  
8 near the Nation and other federally recognized Native Americans living on the Nation  
9 with disabilities; and

10 WHEREAS, the Tohono O'odham Nation will contribute the required 10% match from the  
11 Department of Education Administration budget and the General Cost Pool; and

12 WHEREAS, the Vocational Rehabilitation Program has developed the FY 2011 budget in amount  
13 of \$433,277.00 beginning October 1, 2010 through September 30, 2011 and is seeking  
14 approval of the attached budget.

15 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby  
16 approves the Vocational Rehabilitation Program's FY 2011 budget in the amount of  
17 \$433,277.00 and hereby authorizes expenditure of the funds for the period of October  
18 1, 2010 through September 30, 2011.

19 BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the  
20 Chairperson and any designated official to expend and administer the budget as  
21 attached, provided that any amendments affecting the funds or funding level shall be  
22 submitted for further prior approval by the Tohono O'odham Legislative Council.

23 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30<sup>TH</sup> Day  
24 of JULY, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;  
25 -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI,  
26 Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham  
27 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
28 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
