

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the Bureau of Indian Affairs One Stop Division -477 Budget FY 2011)**

RESOLUTION NO. 10-328

1 **WHEREAS, the Master 477 budget administers all combined federal programs under the**
2 **Education Department One Stop Division from October 1, 2010 to September 30, 2011**
3 **in the combined amount of \$1,062,190.41 with projected allocations; and**

4 **WHEREAS, the Master 477 budget had been developed and cost shared with the Arizona**
5 **Department of Economic Security funding to promote smooth transitional services for**
6 **clients with an effective cost shared to promote de-centralized services; and**

7 **WHEREAS, the Master 477 budget will be modified when federal allocations have been received**
8 **to reflect the actual allocations.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
10 **approve and authorize the expenditure of the FY 2011 Master 477 Budget for the**
11 **Education Department - One Stop Division effective October 1, 2010 to September 30,**
12 **2011 in the projected amount of \$1,062,190.41.**

13 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council approves the FY 2011**
14 **Master 477 Budget for the Education Department - One Stop Division.**

15 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
16 **Nation's Officials, to wit; the Chairman and any official appointed designee is hereby**
17 **authorized to expend the budget, provided however, that any amendments affecting**
18 **the funding or funding levels of this budget shall be submitted for further prior**
19 **approval by this Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30TH Day**
21 **of JULY, 2010 at a meeting at which a quorum was present with a vote of 2,396.80 FOR; -0- AGAINST;**
22 **198.70 [01] NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article**
23 **VI, Section 1 (d)(2)(3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
24 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
26 **Stat. 984).**
