**WHEREAS, the Arizona Department of Economic Security is intended to fund specific Workforce Investment Act (WIA) employment and training programs operated by the Tohono O'odham Nation Education Department's One Stop Division for the period beginning April 1, 2010 to June 30, 2012 in the amount of \$210,283.00; and**

**WHEREAS, the Department of Economic Security - State of Arizona anticipates allocation of funds to the Nation, for FY2011 in the amount of \$210,283.00, the funds allocated are subject to the provisions of the Workforce Investment Act Title 1B; and**

**WHEREAS, the Education Department - One Stop Division has seven (7) program budgets and request to expend these budgets per attached budgets; and these budgets as identified in the following table; and**




