

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the FY 2011 Budget for Bureau of Indian Affairs P.L. 93-638 Master**  
**Contract FY 2007 Roads Discretionary Funds for \$891,295.79)**

**RESOLUTION NO. 10-331**

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**  
2 **Bureau of Indian Affairs under a P.L. 93-638 Master Contract; and**

3 **WHEREAS, in 2005, the Nation negotiated a P.L. 93-638 Master Contract with the Bureau of Indian**  
4 **Affairs which remains in effect; and**

5 **WHEREAS, the Executive Branch has developed the attached FY 2011 Budget for the FY 2007 Roads**  
6 **Discretionary Funds in the amount of \$841,055.00 plus contract support cost of**  
7 **\$50,240.79 for a total of \$891,295.79.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
9 **the attached FY 2011 Budget for the FY 2007 Roads Discretionary Funds in the amount**  
10 **of \$841,055.00 plus contract support cost of \$50,240.79 for a total of \$891,295.79.**

11 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
12 **Nation Chairman, Vice-Chairman and any designated officials are authorized to**  
13 **administer the attached budget, provided, however that any amendments affecting**  
14 **the funds or funding levels that are budgeted shall be submitted for further prior**  
15 **approval by the Tohono O'odham Legislative Council.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 02<sup>ND</sup> Day**  
17 **of AUGUST, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**  
18 **AGAINST; -01- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
19 **Article VI, Section 1 (d)(3)&(f) of the Constitution of the Tohono O'odham Nation, adopted by the**  
20 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
22 **18, 1934 (48 Stat. 984).**
