(Approving the North Communities Fiscal Year 2010 Budget Amendment No. 1)**

**RESOLUTION NO. 10-334**

1 **WHEREAS, North Communities Resolution No. NC-126-09, Sells District Council Resolution No. SD-**  
2 **83-09, and Legislative Council Resolution No. 09-525 approved the FY2010 Budgets for**  
3 **the Sells District and its Communities; and**

4 **WHEREAS, North Communities have identified the necessity to amend their budget to address**  
5 **additional needs of the community; and**

6 **WHEREAS, the attached budget amendment and its justifications has been prepared and**  
7 **approved by the North Communities with Resolution No. NC-88-10; by the Sells District**  
8 **Council with Resolution No. SD-61-10 approving an amendment of the FY2010 Budget.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
10 **North Communities Fiscal Year 2010 Budget Amendment No. 1 to Decrease line item**  
11 **#612 Occasional Appointments by \$2,000.00, #650 Tuition & Registration by \$1,000.00,**  
12 **#710 Utilities by \$1,500.00 and Increasing line items #625 Scholarship & Tuition by**  
13 **\$2,000.00, #727 Building Materials by \$1,000.00, #855 Consumables by \$500.00 and**  
14 **#900 Clothing Grant by \$1,000.00.**

15 **BE IT FURTHER RESOLVED that this does not affect the Sells District Fiscal Year 2010 budgeted**  
16 **amount.**

17 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the Sells**  
18 **District Chairperson and any designated official to expend and administer the budget,**  
19 **as attached, provided that any modifications/amendments affecting the funds or**  
20 **funding levels of the budget shall be submitted for further prior approval by the**  
21 **Tohono O'odham Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 02<sup>ND</sup> Day**  
23 **of AUGUST, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**  
24 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article**  
25 **VI, Section 1 (d)(2)&(3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
26 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
28 **Stat. 984).**
