

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Gu Achi District FY 2010 Budget Amendments for Covered Wells,
Ak Chin, Sikol Himatk, Cababi, North Santa Rosa and San Luis Communities)**

RESOLUTION NO. 10-335

1 **WHEREAS, the Tohono O'odham Legislative Council did convene on August 2, 2010 to address**
2 **issues pertaining to the Nation; and**

3 **WHEREAS, on July 9, 2010, at a regularly scheduled meeting, the Gu Achi District Council did**
4 **approve a budget amendment for Covered Wells Community (*Amendment #3,***
5 ***Resolution #0710-240*) as attached hereto; and**

6 **WHEREAS, on July 19, 2010, at a scheduled special meeting, the Gu Achi District Council did**
7 **approve budget amendments for Ak Chin (*Amendment #2, Resolution #0710-246*),**
8 **Sikol Himatk (*Amendment #2, Resolution #0710-247*), Cababi (*Amendment #2,***
9 ***Resolution #0710-248*), North Santa Rosa (*Amendment #4, Resolution #0710-249*), and**
10 **San Luis (*Amendment #1, Resolution #0710-251*) Communities as attached hereto; and**

11 **WHEREAS, the Tohono O'odham Legislative Council's Budget and Finance Committee did review**
12 **the communities' budget amendments submitted by the Gu Achi District and**
13 **recommend for approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
15 **approve the Gu Achi District FY 2010 Budget Amendments for Covered Wells**
16 **(*Amendment #3*), Ak Chin (*Amendment #2*), Sikol Himatk (*Amendment #2*), Cababi**
17 **(*Amendment #2*), North Santa Rosa (*Amendment #4*) and San Luis (*Amendment #1*)**
18 **Communities as attached hereto.**

19 **BE IT FURTHER RESOLVED that the amendment does not affect the overall portion of the Gaming**
20 **Distribution of \$1,863,072.77 to the Gu Achi District.**

21 **BE IT FURTHER RESOLVED that the Gu Achi District Council has the authority to modify its Fiscal**
22 **Year 2010 budget in accordance with protocols set forth by this Council. Any**
23 **amendments affecting the funds or funding levels of the Gu Achi District's Fiscal Year**
24 **2010 budget shall be approved by the Tohono O'odham Legislative Council.**

25 **BE IT FINALLY RESOLVED that this resolution will be executed in an expedient manner.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 02ND Day**
27 **of AUGUST, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**
28 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article**
29 **VI, Section 1 (d)(2)&(3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
30 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
31 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
32 **Stat. 984).**




