(Approving the Gu Achi District's Fiscal Year 2011 Budget of \$1,705,922.80)**

**RESOLUTION NO. 10-336**

1 **WHEREAS, the Tohono O'odham Legislative Council did convene on August 02, 2010 to address**  
2 **issues pertaining to the Nation; and**

3 **WHEREAS, on July 09, 2010, at a scheduled special meeting, the Gu Achi District Council passed**  
4 **Resolution No. 0710-254 for approval of the Fiscal Year 2011 Budgets for the District's**  
5 **Administration and Communities for operational and direct services to meet the**  
6 **needs of the District and Communities; and**

7 **WHEREAS, the Gu Achi District Fiscal Year 2011 budget was presented, reviewed and**  
8 **recommended for approval by the Nation's Budget & Finance Committee.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
10 **the Gu Achi District's Fiscal Year 2011 Budget in the amount of \$1,705,922.80 as**  
11 **attached hereto.**

12 **BE IT FURTHER RESOLVED that any additional funds coming to the Gu Achi District will**  
13 **automatically be deposited to the District's Savings Account.**

14 **BE IT FINALLY RESOLVED that the Gu Achi District Council has the authority to modify its Fiscal**  
15 **Year 2011 budget in accordance with protocols set forth by this Council. Any**  
16 **amendments affecting the funds or funding levels of the Gu Achi District's Fiscal Year**  
17 **2011 budget shall be approved by the Tohono O'odham Legislative Council.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 02<sup>ND</sup> Day**  
19 **of AUGUST, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**  
20 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article**  
21 **VI, Section 1 (d)(2)&(3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
22 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
23 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
24 **Stat. 984).**
