18		Regulatory Act, 25 U.S.C. §2710 (b) (3); (2) acceptance by the Tohono O'odham
19		Legislative Council of a Certification of Eligible Members submitted by the
20		Enrollment Office and based upon receipt of a properly completed and filed
21		Certificate of Eligibility Verification for a Per Capita Payment for each member; and
22		(3) as to each Minor Eligible Member, establishment of a restricted account at Bank
23		of America for the deposit of such Member's Per Capita Payment; and
24	WHEREAS,	$pursuant \ to \ Resolution \ No. \ 97-452, the \ Tohono \ O'odham \ Legislative \ Council \ adopted$
25		a Revenue Allocation Plan and caused the Plan to be submitted for approval by the
26		Phoenix Area Office of the Bureau of Indian Affairs in accordance with authority
27		delegated to the Area Office by the Secretary of the Interior; and

Accepts and approves the Certification Listing for <u>02</u> Eligible Adult Members for 11 the Initiative Per Capita listing payout distribution. 12 2. Authorizes (a) the transfer of \$4,000.00 from the Initiative Per Capita Investmetn 13 Account to the Initiative Per Capita Checking Account established at Bank of 14 America; and (b) upon the authorized signature of the Nation, issuance of a check 15 on the Initiative Per Capita Checking Account in the amount of (i) \$2,000.00 to 16 each Eligible Member residing in the United States and listed in the Certification 17 Listing of Eligible Members and (ii) \$1,400.00 to each Eligible Member residing 18 outside the United States and listed in the Certification Listing of Eligible 19 Members, with the Balance of \$600.00 withheld and remitted to the Internal 20 Revenue Service pursuant to the requirements of federal law. 21 3. Authorized the Chairman of the Nation to execute such other documents as may 22 be necessary to implement this Resolution. 23 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the disbursement of 24 funds to each additional eligible adult Tohono O'odham member is contingent upon 25 verification of a member by the Enrollment Program and further certification of 26 27 additional eligible adult members by the Tohono O'odham Legislative Council. 28 29 30 31
