

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving American Recovery and Reinvestment Act (ARRA) of 2009 Funding for
the Food Distribution Program on Indian Reservations (FDPIR) FY2010)**

RESOLUTION NO. 10-360

1 **WHEREAS, President Obama signed the American Recovery and Reinvestment Act (ARRA) of 2009**
2 **(H.R 1) into law on February 17, 2009 as Public Law 111-5, which included about \$5**
3 **million for costs relating to equipment upgrades and facility improvement needs for**
4 **Food Distribution Programs on Indian Reservations (FDPIR); and**

5 **WHEREAS, the Tohono O'odham Food Distribution Program submitted their priorities as:**

- 6 **1. Food Distribution Program roof repair.**
- 7 **2. Replace heating and cooling units for the Food Distribution Program office and**
8 **warehouse delivery room.**
- 9 **3. Food Distribution program office space renovation for a kitchen to provide food**
10 **demonstrations for nutrition education services.**

11 **WHEREAS, on July 02, 2010 the Tohono O'odham Food Distribution Program received the Letter**
12 **of Credit in the amount of \$55,000.00 to complete the FDP ARRA projects; and**

13 **WHEREAS, the ARRA project selections are based on approved priorities listing submitted to the**
14 **USDA Western Region office by each FDPIR; and**

15 **WHEREAS, the Executive Branch developed and obtained committee approval of the Food**
16 **Distribution ARRA budget in the amount of \$55,000.00 for the three above mentioned**
17 **priorities.**

18 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
19 **approves acceptance of ARRA funds in the amount of \$55,000.00 for completion of the**
20 **three priorities for the Food Distribution Program.**

21 **BE IT FURTHER RESOLVED that the Food Distribution Program requests authorization to carry**
22 **forward these funds into FY2011 to complete this project; but no later than December**
23 **31, 2010.**

24 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
25 **Chairperson and any designated official to expend and administer the budget as**
26 **attached provided that any amendments affecting the funds or funding level shall be**
27 **submitted for further prior approval by the Tohono O'odham Legislative Council.**
