

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Amending Resolution No. 09-308 for FY 2010 Department of Health and Human Service**  
**Title IV-B, Subparts 1 & 2 budgets for the Division of Child Welfare Services)**

**RESOLUTION NO. 10-361**

1 **WHEREAS, delayed notification was received by the program in May for FY 2010 Title IV-B subpart**  
2 **1 & 2 awards. After review and preparation the budget review process commenced on**  
3 **or around June 7, 2010 and was reviewed by Standing Oversight Committee on June 24,**  
4 **2010 but was halted due to FY2010 Budget Review deadline; and**

5 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**  
6 **Department of Health and Human Services, Child Welfare Division to intervene**  
7 **against child abuse and neglect and to promote safe and stable families; and**

8 **WHEREAS, the Executive Branch developed and obtained Committee approval of the FY 2010 Title**  
9 **IV-B, Subparts 1 & 2 budgets, effective October 1, 2009 through September 30, 2010**  
10 **with Resolution No. 09-308, in the following amounts:**

11 **1. FY 10 Title IV-B, Subpart 1 budget = \$128,812.00**

12 **2. FY 10 Title IV-B, Subpart 2 budget = \$269,013.00**

13 **WHEREAS, the actual award letter for FY 2010 Title IV-B, Subpart 1 is for the amount of**  
14 **\$132,111.00 and FY2010 Title IV-B, Subpart 2 is for the amount of \$251,451.00 a budget**  
15 **amendment is needed to increase Title IV-B Subpart 1 from \$128,812.00 to \$132,111.00**  
16 **and decrease Title IV-B Subpart 2 budget amount from \$269,013.00 to \$251,451.00.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
18 **amends Resolution No. 09-308 to reflect the increase by \$3,299 for Title IV-B, Subpart**  
19 **1 and decrease by \$17,562.00 for Title IV-B, Subpart 2 with the Indirect Cost at 10% for**  
20 **Title IV-B budgets and authorizes the Executive Branch to expend funds for the FY**  
21 **2010 Title IV-B, Subparts 1 & 2 budget amendments attached hereto.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes the**  
23 **Chairman and any designated official to expend and administer the budget**  
24 **as attached, provided however, that any amendments affecting the funds or funding**  
25 **levels shall be submitted for further prior approval by the Tohono O'odham**  
26 **Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup> Day**  
28 **of SEPTEMBER, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**  
29 **AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by Article**  
30 **VI, Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**  
31 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
32 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
