

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Department of Health and Human Service Division of Special**  
**Needs FY 2011 First Things First Family Support Budget)**

**RESOLUTION NO. 10-363**

1 **WHEREAS, the Tohono O'odham Nation has accepted and approved the Intergovernmental**  
2 **Agreement(IGA) FTF/RC026-10-0206-01 with the Arizona Early Childhood Development**  
3 **and Health Board (First Things First) pursuant to Tohono O'odham Legislative Council**  
4 **Resolution No. 10-273; and**

5 **WHEREAS, the Tohono O'odham Nation has consistently supported the development of its**  
6 **youngest members by providing for their welfare through various programs and**  
7 **services designed to meet their special needs; and**

8 **WHEREAS, the Executive Branch developed and obtained committee approval of the following**  
9 **budget as attached and incorporated by this reference, to be effective July 1, 2010**  
10 **through June 30, 2011 and request authorization to expend funds First Things First**  
11 **Family Support Budget with IDC rate amount of \$13,385.64 for a total budget of**  
12 **\$147,242.00.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
14 **the First Things First Family Support Budget for the Period July 1, 2010 through June**  
15 **30, 2011.**

16 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
17 **Executive Branch to expend funds for the program listed above and as attached in the**  
18 **amount indicated, effective July 1, 2010 through June 31, 2011.**

19 **1. Accepts the First Things First Family Support Budget - with an IDC rate amount of**  
20 **\$13,385.64 for a total budget of \$147,242.00.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
22 **Nation's Official, to wit, the Chairman, Vice-Chairman and any designated official are**  
23 **authorized to negotiate and execute the grant, provided however, that any**  
24 **amendments affecting the funds or funding levels of the grant shall be submitted for**  
25 **further prior approval.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup> Day**  
27 **of SEPTEMBER, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**  
28 **AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by Article**  
29 **VI, Section 1 (d)(2) and (f) of the Constitution of the Tohono O'odham Nation, adopted by the**  
30 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
32 **18, 1934 (48 Stat. 984).**
